## Leney re-elected Association president

In a unanimous vote, William H. (Bill) Leney of Danville, Calif., was re-elected president of the Chevron Retirees Association (CRA) by delegates attending the May 20-22 annual meeting in Pittsburgh, Pa. It was the Association's first meeting in Pittsburgh and the second to be held in the North Atlantic Seaboard Area dating to Philadelphia in 1992.

Participating in the CRA's two-day business meeting were 96 delegates and three members-at-large who

represented an amalgam of male and female retirees from Chevron, Texaco, Gulf, Caltex, Chevron Canada, Warren Petroleum, Getty, Skelly, Tenneco, Standard of Kentucky, Standard of California and Unocal.

## Robertson gives overview of Chevron financials, projects, growth, safety

In his initial appearance as a keynote speaker at a Chevron Retirees Association annual meeting, Chevron Corporation Vice Chairman Peter Robertson wowed attendees with his in-depth discussion of record earnings, devastating hurricanes, outstanding offshore discoveries, significant major projects, the Company's best-ever safety record and more.

He greeted retirees, spouses and guests with "I get to do a lot of speaking in a lot of different places and to a lot of audiences all over the world. But I can assure you that there's no place I'd rather be than have this opportunity to speak to a group of people like are represented here, that really helped to build Chevron and make it, in a large part, the great Company it is today."

## President's Q & A Letter

### What is the Chevron Retirees Association? That's something for all to think about

Twelve years ago, our next door neighbors moved to Pittsburgh, Pa. We have kept up with them through that period with Christmas cards and were amazed as the years passed how grownup their daughters had become. While in town for the recent Annual Meeting, we had a chance to have dinner with them. When I told them why we were in town, they asked, "What is the Chevron Retirees Association?" I think that's a good question for us all to think about.

Our Association is an organization of 100 independent and autonomous chapters around the country and Canada. It was founded in 1971 to maintain contact with Chevron Corporation for the dual purposes of (1) improving the economic conditions of retirees from Chevron and its legacy companies and (2) urging its retiree members to support the Company where most of us spent our careers. That support remains in the Public Affairs and political arenas.

Through study and research, we also document problems our retirees encounter so we can bring them to the attention of Company management for satisfactory solutions. During efforts that have spanned more than a generation of retirees, we have developed a very cordial working relationship with Company management.

I have talked with many non-Chevron people about what we do and I truly believe our relationship is unique in corporate America. Many other company retirees have social clubs, enabling them to meet on occasion to reminisce about "the good old days," but they don't have the formal and successful working relationship with their former employer that we have jointly maintained.

When we say our chapters are independent and autonomous, that is exactly what we mean. The Association will make every effort to advise, assist and help chapter leaders. But none of our recommendations are mandatory. Instead, we believe chapter presidents and the other officers, who are closest to their members, know what works best for them. Most members join a chapter for social reasons because they do not want to lose contact with their fellow workers. This is a laudable reason.

However, as mentioned earlier, it is your Association that represents you in working closely with Chevron staffers in helping to resolve various problems, particularly those related to medical coverage. In turn, we have always promoted "paid chapter membership" because we are convinced that the more members we represent, the greater will be our influence with Chevron Management.

When the CRA was founded, many retirees regularly wrote their politicians about issues likely to impact the Company. In more recent years, retirees were rarely encouraged to take similar political positions in favor of the Company. The Association's relationship with Chevron in this area had become a one-way street.

Now I'm pleased to say we have a new opportunity to again make it a two-way cooperative effort. At a special workshop conducted for Annual Meeting delegates, Robert Walker of Chevron Public Affairs outlined an exciting new website that is under development. It is designed to permit those retirees with computers to easily and quickly respond to political issues affecting the Company.

By simply entering our name and address, then with the following click of a mouse, we will be able to send a letter - in support of a Chevron position - to Congressmen, Senators and elected representatives in our state legislatures. Also, we will have the option of changing a prewritten letter to express our feelings on a particular issue.

When operational, the website will be managed by an independent company that will protect our privacy. That firm's report to Chevron will only give the amount of letters sent on a specific issue and not the content or names of participants. Upon its availability, we will publish the website address through the Retirees Email Roster; via chapter presidents, who can forward it to those on their chapter email lists; and in Encore. We hope retirees will take advantage of this opportunity to help the Chevron organization.

Making important and informative presentations at the CRA's annual meeting were a trio of Chevron guests. They included keynote speaker Peter Robertson, vice chairman of the Board of Directors; Claudia Polidori, manager, U.S. Benefits; and Robert Walker of Corporate Policy, Government and Public Affairs.

Introduced at the business meeting were three new area vice presidents, including Bill Merkel, The Plains; Mike Riley, Midwest; and Jim Thomas, South Texas. In turn, President Leney gave certificates of recognition and thanks to outgoing area vice presidents from those areas, including Clyde Crittenden, The Plains; Charlie Rhoads, South Texas; and Don Satterly, Midwest.

Returning area vps are Robin Backstrom, Intermountain; Ernie Breaux, Gulf Coast; Daryl Brennick, Northwest U.S./Alaska; Bruce Fraser, Canadian; George Powell, South Atlantic Seaboard; E. Kevin Ryan, North Atlantic Seaboard; Phil Stone, Southern California; and Sy Yuan, Northern California/Hawaii - plus Bill Mather, Unaffiliated Area.

It was announced the Association has 18 new chapter presidents, including one woman.. Altogether, the CRA has 100 membership chapters, including two in Canada.

Well received and attended at the Pittsburgh meeting were workshops offering suggestions for publishing a chapter newsletter, guidelines on the parameters and importance of "paid" CRA membership, and a government affairs program that focused on advocacy opportunities for retirees in writing their Congressmen. Workshop chairs were Maree Stone, newsletters; Bill Merkel and Clyde Crittenden, membership; and Chevron's Walker. Delegates were asked to provide feedback about the workshops on an evaluation form.

Providing an update of the next three annual meetings were Sy Yuan, San Francisco, May 19-21, 2007; Mike Riley, Louisville, Ky., May 17-19, 2008; and Robin Backstrom, Las Vegas, May 17-19, 2009. In a scheduling change to obtain better hotel rates, the Vegas meeting will be held Sunday through Tuesday.

In other association business:

- Delegates disapproved a motion to require the Association's budget be balanced every year. The reasoning: such a requirement could lead to arbitrary rather than the best estimate forecasting of revenues and/or expenses.
- Delegates defeated a motion to limit MidYear Meeting attendees to one past president plus others the President may invite.
- Delegates passed a motion to change the "purpose" of the MidYear meeting from the "review of issues" to "the recommendation of issues" to be brought before the delegates for approval at the annual meeting.
- Delegates passed a motion delaying a review of the "boundaries and small chapter economics" - which refers to chapters with 30 members or less - until 2007-08 due to the potential influx of members from Unocal and Texaco.

Altogether, conference attendees totaled 180, including delegates, members at large, Chevron speakers, guests and spouses. E. Kevin Ryan, the North Atlantic Seaboard vice president, was host area VP for the annual meeting and Rose Marie Ritter, past president of the Gulf Research Center Annuity Association Chapter, was Host Committee Chair.

## Encore Benefits Corner

### ***Chevron remains in holding pattern regarding many aspects of Medicare D***

I just returned from the CRA Annual Meeting and, as always, it provided lots of topics for this column. Claudia Polidori, Chevron's manager of U.S. Benefits, made her usual outstanding presentation and provided the key issues which are addressed in this column.

The issue probably foremost on all our minds is: "What is Chevron's position with regard to Medicare D for 2007?" Claudia made it clear that the corporation is still in a holding pattern concerning many aspects of Medicare D. Information flow from the government with regard to implementation is slow. However, she did provide some insight as to what we can expect when September/October, and the important Open Enrollment Period, comes around.

As previously reported, Chevron will take the role as secondary provider to prescription drug service for 2007. MEDCO, now recognized as a Medicare D plan provider, will continue as Chevron's PDP (prescription drug provider). Again, it is important to note that when signing up for a plan in 2007, if you want the Chevron medical portion of the plan, you must sign up for Medicare D through Chevron. DO NOT sign up for both a Chevron plan and an unaffiliated Medicare D plan.

Claudia also gave attendees an update on the Chevron Benefits Connection. Significant upgrades have been made to this internet tool, which warrants all retirees with web access to check it out. By logging onto Benefits Connection, you can make changes to your personal data; access medical plan descriptions; and review specific plan coverage for your plan. Additional information of value is updated and posted regularly.

Give it a try. You access it by logging onto <http://hr2.chevron.com> and then clicking on Benefits Connection.

For our new Unocal retirees, Claudia indicated that active Unocal employees will be brought into the Chevron plans effective July 1. Retirees will be brought into the Chevron medical plans on January 1, 2007, and will participate in the normal Open Enrollment period scheduled later this year. The first letter, which will contain all specifics, is scheduled for mailing to retirees at the end of August.

I know many are concerned with the ever increasing cost of health care. So am I. Our Company works with numerous consortiums to seek reductions in health care premiums and prescription drug costs. Chevron regularly reviews our existing plans and seeks ways to improve or add to the options our retirees have available to them.

Our recipient is an area vice president who has demonstrated not only that he was ready to help whenever a problem occurred but also has been one of our most dedicated vice presidents."

Crittenden is the outgoing vice president for The Plains Area, comprised of 10 chapters in Texas and Oklahoma; was a founding member with wife, Laurin, of the North Central Texas Chapter in 1994; and received a 1999 CRA Public Service Award for many years of volunteer work at the Happy Hill Farm Home and Academy.

## Edmondson, Thomas receive Public Service Awards

Mrs. Eleanor Edmondson of the Oklahoma City Chapter and James W. Thomas, president of the Chevron/Gulf Retirees Chapter in Port Neches, Texas, are the recipients of Chevron's Public Service Awards for 2006. At the CRA's annual meeting banquet in Pittsburgh, Thomas accepted a certificate of award from Peter Robertson, Chevron's vice chairman. Edmondson was unable to attend.

The Company-sponsored program was established in 1998. It annually recognizes outstanding work performed in their home communities by individual Chevron retirees, surviving spouses and chapters. Awardees also receive public awareness and recognition of their significant volunteer activities.

Each award is accompanied by a \$1,000 contribution from Chevron Corporation to the non-profit organization of the recipient's choice. Thomas' prize is being divided between The Salvation Army in Port Arthur and Port Neches Senior Citizen Foundation. Edmondson selected the Women's Service and Family Resource Center in Chickasha, a temporary shelter/counseling service for abused women.

Since his 1989 retirement, Thomas' volunteerism has been extensive. It was highlighted last fall by his dedicated work with the Salvation Army in Port Arthur and Port Neches following the disastrous effects on those communities by Hurricanes Katrina and Rita. After Port Arthur suffered a direct hit from Rita, Thomas "worked four

hours a day, seven days a week, helping serve hot meals for breakfast and dinner to feed police, fire and city employees. This went on for ten weeks. My own home was not livable and I had to stay at my brother-in-law's home using a generator since we had no electricity or phone service."

Culminating 30 years in the Accounting Department, Thomas retired "from the Chevron-Gulf Port Arthur Refinery. While at Chevron, I chaired the United Way Fund for ten years." His volunteerism includes the Port Neches Chamber of Commerce, Port Neches Advisory Board for Senior Citizens, Port Neches Senior Citizen Foundation Board, the AARP branch of Tax Counseling for the Elderly and a board member of the Gulf Employees Credit Union 29 years.

Mrs. Edmondson, the surviving spouse of John Edmondson, a Texaco geophysicist for 35 years until his 1980 retirement, is equally active in her community.

She's a docent for Grady County Historical Society, a patient representative for Grady County Memorial Hospital Auxiliary, a patron of the non-profit Resurrection House for the homeless, a member of the Sales Tax Oversight Committee for the Chickasha mayor, vice president of Grady County Retired Educators and the list goes on and on. In June, to honor her Chevron award, the Chickasha Chamber of Commerce held a special community reception for Mrs. Edmondson.

John Maerzke coordinates the Awards program for CRA as its Public Affairs Committee chair.

Among other nominees for the 2006 Public Service Awards were Jim Childers, Contra Costa Chapter; Ken Gillespie, San Francisco Chapter; Robert Henderson, Texoma Chapter; Carol Hobbs and Paul Hopson, Permian Basin Chapter; Ken Miller, Singing River Chapter; David Mitchell, Marin Chapter; Denny Saunders, Tulsa Chapter; and Judith Wenker and Charles Wooten, San Diego Chapter.

## How to help Chevron get its energy message out

Near the conclusion of his keynote address to retirees, Chevron Vice Chairman Peter Robertson looked out at the intense audience of friendly faces and said "We need your help to get out the real story of Chevron today, which is one of innovation, collaboration and conservation."

He had earlier highlighted Chevron's many recent accomplishments in the development of new global energy supplies, its achievements in advances of technology and its status as the world's largest producer of renewable energy (see renewable energy story below).

Despite such accomplishments, he explained, "In recent months that story has been overshadowed by outrage and political posturing over gas prices and industry earnings. We're working diligently to tell our story and the truth about energy to consumers, policy makers, influencers and elected officials at every level of government. But to most effectively tell our story, we also need your help as Chevron constituents with an important stake in our Company and our industry."

He said the retirees' knowledge of the industry and strong commitment to Chevron can give a huge boost to the Company's efforts to better educate the public.

More explicitly, he said, "You can help us defeat those new laws and regulations, at both the state and federal levels, that would inhibit our efforts to find and produce the range of energy supplies our nation needs. You can be the face and the voice of the Company you helped to build in letters to the editor of your local newspaper, in phone calls, letters or emails to your elected representatives, and in conversations with your families, neighbors, friends and golf partners.

"Now, more than ever, it's important to be engaged in communicating the real story about energy. We need your help in a grass roots effort to educate the public and government about our industry and the value it provides to our society and our quality of life. If you live in California, you can help us mobilize and defeat the oil tax initiative that's on the November ballot."

To assist retirees in advocacy efforts, the Company is in the process of establishing "a grass roots website." It is designed to give you the information and tools you need to help get Chevron's energy messages out on specific legislative issues.

More details on this will be published in Encore and on the Association's Email Roster when the site is active.

## Chevron renewable projects dovetail with consumer energy poll

At Pittsburgh, Vice Chairman Peter Robertson cited a recent Chevron opinion poll of a thousand American adults on the subject of energy. Some findings were:

- Strong concern about U.S. energy supply and its effect on U.S. competitiveness.
- Belief it is in America's best interest to develop more domestic sources of energy.
- Desire for the U.S. energy industry and the government to join together to develop energy solutions for the future.
- Support for a wide range of proposals - energy incentives, energy investments, new projects and approaches to help secure the U.S. energy future.

## **Robertson calls 2005 an extraordinary year**

Following the showing of a short Company video, he promptly provided attendees with an overview of 2005, calling it "an extraordinary year by any measurement. It also was one of great accomplishments coupled with unprecedented challenges.

"For example, we achieved record earnings of more than \$14 billion in reported net income, our second year in a row of record earnings, and a return on capital employed of 22 percent. Our total debt increased by \$1.6 billion from a year ago. We ended 2005 with a total debt to total debt-plus-equity ratio of 17 percent, down from 20 percent at year-end 2004. These strong earnings and cash flows have allowed us to continue to return cash to our stockholders.

"In 2005 we increased our quarterly dividend by 12 ½ percent, the 18th consecutive increase in as many years. And last month we declared a quarterly dividend of 52 cents a share, an increase of 15 ½ percent, compared with the previous dividend of 45 cents that we announced this past January. And we completed a \$5-billion stock buyback program in 2005 and launched another buyback program of up to \$5-billion over three years. Our strong earnings also allowed us to fund the capital and exploratory budget of approximately \$15 billion for 2006, roughly 34 percent higher than our 2005 spending level, and the highest annual spend in Chevron's history."

He also was pleased by the Company's safest year ever, in which it reduced the injury rate by 20 percent compared with 14 percent for 2004. Moreover, that was accomplished in a year that will be largely remembered for the devastating hurricanes of Katrina and Rita on the U.S. Gulf Coast.

He said, "Those hurricanes caused a great deal of destruction and damage to our operations on the U.S. Gulf Coast and the communities where our employees live. I also know that some of you suffered devastating losses. Thankfully, no Chevron employee was killed during the hurricanes or their aftermath. Instead, we witnessed one of this Company's finest moments."

Robertson described how the men and women of Chevron worked nonstop to locate colleagues, open their homes to others who were homeless and provided food, water, clothing and medical support to those directly affected by the storms. The Company immediately made an initial donation of \$5 million and Chevron employees worked around the clock to restore production and refining capabilities.

Prior to the hurricanes, Robertson said the Company continued to build momentum for long-term profitable growth in 2005 with its acquisition of Unocal - and the benefits the deal brought to the Company's reserves and production. It also strengthened Chevron's position in key upstream strategic growth areas. Those regions include the Asia Pacific, where Chevron now is a top tier producer of natural gas; the Caspian Region of Central Asia; and the U.S. Gulf of Mexico.

Robertson pointed out, "The integration of Unocal into Chevron is substantially complete, and we already are seeing benefits to our bottom line from that acquisition. Also, the \$4 billion in first quarter earnings that we recently reported, up 49 percent from 2005, were driven by the positive impact of the Unocal acquisition along with rising oil and gas prices and increased throughput in our refineries.

"In 2005, we also continued our industry-leading exploration program by making 31 new discoveries, resulting in a 58 percent success rate. We had major discoveries in the deepwater Gulf of Mexico and offshore Venezuela, Trinidad and Tobago, and Nigeria."

Continuing his focus on 2005, Robertson said the Company made good progress on its major projects offshore Nigeria, Angola, Australia and the U.S. Gulf of Mexico plus Tengiz in Kazakhstan. "These projects are essential to bring on new production and new reserves over the next five years. When these big five projects come on-line, and as we continue to efficiently produce as many barrels as we can from our existing operations, we believe Chevron can achieve production growth in excess of three percent per year over the next five years - and I think beyond that."

On the downstream side, he mentioned that the Company has aggressive efforts under way to increase utilization of its refineries, which includes executing several projects in 2006 to extract more value from each barrel of crude oil. It also is implementing several projects to increase refinery scope and flexibility.

Robertson said, "All of these business milestones, that I have reviewed with you, and our strategies going forward, are taking place in an environment that grows more challenging every day. It's clear that energy is now at the top of the global agenda. You are well aware that the global energy industry is undergoing fundamental changes - increased product demand, geopolitical instability, resource nationalism and a more challenging frontier of energy supplies in such areas as ultradeep water and oil sands.

"The result of all these factors is that the global oil supply and demand are more tightly balanced than at any time in the last quarter century."

## **Chevron is world's largest producer of renewable energy**

"What Americans are saying," reported Robertson, "tracks closely with Chevron's efforts to find solutions to the energy challenges of the future. Chevron, for example, is the world's largest producer of renewable energy. The biggest component is geothermal energy in the Philippines and Indonesia."

In his keynote address, he also mentioned other alternative and renewable efforts:

"We're partnering with General Motors and the state of California to develop and test a new ethanol fuel blend. We're working with the U.S. Department of Energy and Hyundai to develop practical applications of hydrogen fuel cell technology. We're partnering with a public transit system in the San Francisco Bay Area to provide hydrogen fuel for a fleet of experimental buses. And we announced our investment in Galveston Bay Biodiesel, a Texas-based company that is building one of the first large-scale biodiesel plants in the U.S. The biodiesel will be produced from soy beans and other renewable feedstocks.

"At the same time," said Robertson, "we believe an important part of the energy equation is to use energy more efficiently and to extend the life of the supplies we do have. Conservation and efficiency are the cheapest, most reliable forms of new energy.

"As a case in point, our Chevron Energy Solutions subsidiary recently completed an energy conservation project for the U.S. Postal Service at two of its San Francisco facilities. It will reduce energy costs by \$1.2 million annually."
