Forbes and Newsweek rank Chevron a top workplace

Dec. 28, 2023 -- *Forbes* and *Newsweek* listed Chevron as one of 2023's best workplaces. It was among two oil and gas companies to receive recognition for LGBTQ+ workplace inclusion. Chevron was also singled out for its wider diversity efforts. The kudos came after the media outlets worked with research firms to evaluate factors like working conditions, diversity, compensation and development potential.

Chevron earns top marks on corporate equality index for 18th consecutive year

SAN RAMON, Calif., Dec. 14, 2023 – Chevron Corporation (NYSE: CVX) today announced the company received a score of 100 on the Human Rights Campaign Foundation’s 2023-2024 Corporate Equality Index (CEI) for the 18th consecutive year.

Chevron is among other major U.S. businesses that received a CEI rating of 100 points along with the new Equality 100 Award: Leaders in LGBTQ+ Workplace Inclusion, a distinction recognizing companies that meet or exceed elevated criteria focused on four central pillars:

- Non-discrimination policies across business entities
- Equitable benefits for LGBTQ+ workers and their families
- Supporting an inclusive culture
- Corporate social responsibility

“Chevron is extremely proud to be recognized by the Human Rights Campaign Corporate Equality Index for the 18th consecutive year,” said Joesetta Jones, Chevron’s chief diversity and inclusion officer. “We strive to create a workplace where all employees feel safe, heard and respected. While no place can be perfect, it is wonderful to

have our efforts validated. Chevron has worked to support its LGBTQ+ community long before it was an industry standard, and we will continue leading the way to a brighter, more inclusive future for all employees.”

Chevron announces \$16 billion 2024 capex budget

SAN RAMON - Dec, 6, 2023 — Chevron Corporation (NYSE: CVX) today announced an expected organic capital expenditure range of \$15.5 to \$16.5 billion for consolidated subsidiaries (capex) and an affiliate capital expenditure (affiliate capex) budget of approximately \$3 billion for 2024.

Upstream spending in 2024 is expected to be about \$14 billion. Of this planned expenditure, two-thirds is allocated to the United States, including approximately \$6.5 billion to develop Chevron’s U.S. shale and tight portfolio, of which around \$5 billion is planned for Permian Basin development. About 25 percent of U.S. upstream capex is planned for projects in the Gulf of Mexico, including the Anchor project, which is expected to achieve first oil in 2024.

Downstream capex is expected to be roughly \$1.5 billion, with 80 percent allocated to the United States. Corporate and other capex is projected to be about \$0.5 billion.

Included in the upstream and downstream budgets is approximately \$2 billion in lower carbon capex to lower the carbon intensity of traditional operations and grow new energy business lines. Chevron’s Geismar renewable diesel expansion project is expected to start-up in 2024.

Nearly half of affiliate capex is planned for Tengizchevroil’s FGP / WPMP project in Kazakhstan and about a third is planned for Chevron Phillips Chemical Company, including the Golden Triangle Polymer Project and Ras Laffan Petrochemical Project. WPMP field conversion is forecasted to begin start-up in the first half of 2024.

“We’re maintaining capital discipline in both traditional and new energies,” said Chevron Chairman and CEO Mike Wirth. “These investments are expected to underpin durable free cash flow growth to support our objective of returning more cash to shareholders.”

With the acquisition of PDC Energy, Chevron announced an annual capex guidance range of \$14 to \$16 billion through 2027. On October 23, 2023, Chevron announced that it had entered into an agreement to acquire Hess Corporation. This acquisition is expected to close in the first half of 2024, subject to Hess shareholder approval, regulatory approvals and other customary closing conditions. Following closing of the acquisition, Chevron’s annual capex budget is expected to be between \$19 and \$22 billion.

Chevron Retiree Spotlight

Dennis Dauphin: Preserving memories of Vietnam

After Chevron retiree Dennis Dauphin served in the Vietnam War, he was determined to “gather the memories so they wouldn’t be lost to history.” With this goal in mind, he created a website, themightyninth.org, that recaptures the fighting spirit of his fellow members of the U.S. Army’s 2nd Battalion, 9th Field Artillery.

Decades after he assembled the first reflections of unit members, he continues to add content under such headings as “War Stories,” “Tour of Duty & Memories” and “First Day/Night in Vietnam.” And he honors the dead in a section titled “Our Deceased Brothers.”

“After I decided to create the website, my former artillery comrades trusted me with their memories and memorabilia,” says Dennis. “Their war stories reveal a personal side of the war that I didn’t see in any magazine or newspaper.”

Dennis served in Vietnam as a 1st lieutenant from 1966 to 1967 after graduating from ROTC (Reserve Officer



Training Corp) while at Loyola University and going through Officer Basic Training (OBC) at Fort Sill, Oklahoma. "At Fort Sill, they didn't allow for any failure," Dennis recalls. "We had hours and hours of intense training. Still, I had no idea Vietnam was on my radar. But I'd been given artillery training, and that skill was in great demand in Vietnam."

His memories of the war center mainly on the strong bonds he shared with his fellow GIs. He is especially proud of the role played by the artillery in helping to provide cover for the infantry as it engaged in "search and destroy missions." Yet he continues to feel that the U.S. was engaging in "a limited war" rather than pushing for victory. That disappointment was reinforced when he returned home to the U.S., where he found civilians seemingly indifferent to the war effort. "They didn't understand what it had been like to fight in the jungle and risk our lives."

He decided against being a career officer, but instead rose through the U.S. Army Reserves to become a Lieutenant Colonel, instructing Enlisted and Officer personnel at the USAR School in New Orleans in a range of operational skills. He expanded his lecturing capabilities after acquiring an additional branch qualification in AMEDDS (the Army's medical branch). He served his Summer Camps lecturing at the medical academy at Fort Sam Houston where he taught the Army's physicians and nurses how their skills would be employed in a combat zone. "I also lectured on nuclear, biological and chemical warfare and the kind of shells the military used in battle – a whole range of subjects that made me a popular lecturer at Fort Sill during my Summer Camps there."

Dennis managed this role while pursuing a career in Procurement at Gulf Oil and later at Chevron from 1967 to 1999. After his retirement, he served in various roles for CRA, including a stint as national president of the organization from 2013 to 2015. He is extremely proud of being chosen to serve as the national president as well as his long association with the CRA.

His other volunteer activities included the vice presidency of the Alhambra Society to support children with Down's Syndrome. "I visited the homes for many of these children and recognized how much they were suffering for lack of funds," Dennis says. "So I worked to raise money to help them live with more dignity."



Another of his volunteer efforts has been to play Santa each year for the Regional Homes, which serves mentally handicapped and emotionally challenged children, teens and adults.

He has also been deeply involved in several Community Theaters on the Gulf Coast, where he has served on the Gulfport Little Theatre Board of Directors, been the webmaster, and technical director in charge of sound and lights. With the Biloxi Little Theater, he has been responsible for the sets and scenery. And he has capped his backstage work with acting roles in more than 20 musicals, comedies, and dramas. "My involvement in community theater started when I accepted a transfer to Chevron's Pascagoula (Miss.) Refinery," says Dennis. "My son Danny got interested in the community theater and ended up appearing in eight plays. (He now has a "sideline job" as a professional actor in Chicago theaters). My daughter then said, 'I can do that too.' Pretty soon, I was serving as technical director and helping to raise money for the theater. Then, lo and behold, someone on the staff said, 'We want you to be on stage.' Fortunately, I'd been in the choir as a young boy. And before I started to perform, I worked with a vocal director and a pianist. That gave me the confidence to go in and do it."

He adds, while I was fully engaged in community theater as the tech director, Board member, set builder, actor-singer-dancer, etc., my loyal wife Jackie employed her excellent sewing talents to make many costumes for the children of families who couldn't afford them. We were also the producers of over 25 children's musicals. Over the years, Jackie's eyesight would not allow to sew anymore."

After his years on and back stage, Dennis retains committed to one volunteer activity above all: maintaining the site for his beloved artillery unit.

Ron Shirey: Finding a program for success

Ron Shirey describes his hiring by Gulf Research and Development Co. (GR&DC) as “the conduit for my professional career.” A high school graduate who had just been discharged from the U.S. Air Force, Ron joined an organization where he was surrounded by brilliant scientists “doing a five-to-ten-year look-ahead.” While in the service, he had tested well in mechanical and electrical areas, worked with radar on fighter aircraft, and gone to instructor school. These attributes and experiences served him well when he applied for a position at GR&DC.

After joining the organization as a pilot plant operator, he was transferred to its Data Center as a computer operator in 1964 – just as information technology was emerging as a viable field rather than as an intriguing curiosity. While in that position, Ron was assigned to the night shift, which freed up his days to pursue a degree in computer science from Penn State University. He subsequently took a leave of absence but worked at GR&DC during school breaks as a programmer on IBM’s Scientific Subroutines projects, before graduating in 1969. “I loved working there,” says Ron. “I became president of the employee club and made so many friends that people kidded me about having a personality that didn’t match the stereotype of the IT nerd.”

At Gulf, he also met his future wife, Fran. “I did something real romantic on one of our first dates, taking her to a Penn State football game packed with 92,000 fans.” She is also a Gulf heritage Chevron annuitant and has taken over his last role as president of the Gulf Research Center Annuitants Assn. Chapter (GRCAA).



Applying his technical skills

He continued to apply his technical skills at GR&DC and Gulf Oil, becoming database administrator in 1977 before being promoted to manager of the group. In 1985, after the company merged with Chevron, Ron joined Presbyterian University Hospital as manager of Computer Operating Systems before becoming database administrator at Duquesne Light Co. prior to his retirement in 2000. As computers became more central to daily life, Ron especially enjoyed “the opportunity to help people get needed information for their work through trial and error.” He continues, “I especially liked sharing my wide knowledge about how operating systems were connected.”

Maintaining his affiliation

After leaving GR&DC, he retained his ties to his long-time organization, participating in the Gulf Research Center Annuitants Assn. Chapter. That affiliation continues today, with his wife Fran writing and editing the chapter’s triannual newsletter and Ron helping to strengthen the link between that group and CRA. He served as the president of GRCAA for eight years before becoming CRA’s communications chair – a role that called for him to apply his computer skills as he maintained the organization’s informative website.

Taking to the air

During his years at Gulf, Ron also helped develop the company’s Flying Club, which gradually grew from 15 to 30 members. After earning his pilot’s license, Ron often enjoyed taking to the air on hops as extensive as 300 miles. He subsequently got his glider’s license and relished his time on solo journeys. In recent years, he has translated his love of aviation to remote-control aircraft flying. “As a youngster, I’d loved building models,” Ron says. “And remote-control flying is a good challenge for my hand/eye coordination. I’m proud to say I can still fly those model planes well.”

He has ample other interests, including golf, biking, volunteering at church, calling Bingo games, and traveling in their motorhome RV with his wife Fran. And for him, “the whipped cream is having our son and two grandchildren living right across the street. Having dinner with the granddaughters after school is a special treat. We have enjoyed rebuilding a large tree house for the grandchildren that was once used by our son and daughter.”

2024 COLA

Social Security and Supplemental Security Income (SSI) benefits for more than 71 million Americans will increase 3.2 percent in 2024.

The 3.2 percent cost-of-living adjustment (COLA) will begin with benefits payable to more than 66 million Social Security beneficiaries in January 2024. Increased payments to approximately 7.5 million SSI recipients will begin on December 29, 2023. (Note: some people receive both Social Security and SSI benefits)

Medicare Part B Premium

Medicare's Part B standard monthly premium will increase to \$174.70 (for most) in 2024, a \$9.80 increase from this year, the Centers for Medicare & Medicaid Services (CMS) announced October 12th Medicare's annual open enrollment period began October 15th and continued through December 7th.

The premium increase comes on the heels of a decrease in 2023 in the Part B monthly charge. Medicare Part B covers doctor visits, diagnostic tests, and other outpatient services. The annual Part B deductible will also rise, to \$240 in 2024 from \$226 this year. CMS attributed the higher premiums and deductibles mainly to increases in health care spending.

An AI Article on taking Social Security Benefits

We hear so much about the dangers of AI and what it might mean for the future of certain jobs. I thought I'd give AI an opportunity to help me write this quarter's benefit newsletter. I posed the following question to Google's Bard AI, "Write me an article about the pros and cons of taking social security benefits early." This is what Bard AI came back with.

When contemplating retirement, one of the biggest decisions involves claiming Social Security benefits. While claiming early seems alluring for immediate financial relief, the long-term impact can be significant. - *Earnings Limit: Early claimants face income limits until reaching FRA. Exceeding these limits results in temporary benefit reductions.*
- *Cost-of-Living Adjustments: Early claimants receive smaller yearly cost-of-living adjustments (COLAs), further eroding purchasing power over time.*

Playing the Waiting Game:

Pros:

- *Larger Payouts: Delaying benefits results in an 8% increase for each year past FRA, up to age 70. This can significantly boost lifetime income, especially for those with longer lifespans.*
- *Future Flexibility: Waiting preserves options. Claiming at FRA allows switching to spousal benefits if advantageous, while waiting until 70 offers the highest possible payout.*
- *No Earnings Limit: After reaching FRA, work income no longer affects benefits.*

Cons:

- *Delayed Income: This strategy requires alternative income sources for living expenses until claiming begins.*
- *Market Risk: Delayed claiming exposes retirement savings to longer market fluctuations, potentially eroding their value.*
- *Uncertain Future: Unforeseen health issues or shorter lifespans might negate the benefits of waiting.*

Ultimately, the best decision depends on your individual circumstances. Consider your:

- *Financial health: Retirement savings, alternative income sources, and expenses.*
- *Health and life expectancy: Family history, personal health, and anticipated lifespan.*
- *Retirement goals: Desired lifestyle, travel plans, and potential work continuation.*

Seek professional guidance from a financial advisor or Social Security Administration representative to analyze your specific situation and make an informed decision. Remember, claiming Social Security is a major financial decision – choose wisely!

AVIS Rental Car Discount

When it is time to book your 2024 vacation travel and need a rental car, don't forget to check out the AVIS discount on the ChevRec BenefitHub website. The AVIS discount can save you up to 25% off base rates and it is the same corporate discount used by Chevron employees. This is one of the best discounts available. I booked a car last summer using this discount while on a baseball trip with friends. We picked up the car in one location (Toledo) and dropped it off at another location (Cleveland). And anyone who has ever booked that type of reservation knows how expensive that can be. Using the discount, the cost dropped from \$400 to around \$150. No guarantee everyone will see that type of savings, but it's a great deal.

Download the completed Retiree AVIS Card and bring that with you. You can find it on the AVIS page. You may need to present it at the local AVIS counter. Also, when booking your reservation enter chevrec@chevron.com when prompted for company email. Both these items let AVIS know you are a verified Chevron retiree able to take advantage of the discount. You can still use your personal email address as contact information for the reservation.
